RESOLUTION NO. 82

A RESOLUTION REQUESTING THE CHIEF OF THE NATIONAL
BUREAU OF INVESTIGATION, MANILA, TO SEND TO OR-
MOC CITY TWO AGENTS TO EXAMINE AND DETERMINE
THE GENUINENESS AND LEGALITY OF SOME CONFUSING
RECORDS OF TRANSACTIONS OF ORMOC CITY.

"WHEREAS, this Board has come to know of a cer-
tain voucher credited to a certain employee of the
Engineering Department, this city, which to the belief
of this Board has been audited and paid anomalously;

"WHEREAS, the fact that this Board doubted as to
the veracity and authenticity of said voucher, this
Board conducted an inquiry on the city treasurer and
the city auditor;

"WHEREAS, this Board has heard full explanations
from the two city officials aforementioned but while
the city treasurer explained his side of the issue to
the entire satisfaction of this Body, the city auditor
could not sufficiently satisfy this Board with his ex-
planations;

"WHEREAS, it is the belief of this Board that simi-
lar irregularities had been tolerated or going on for
years already; and

"WHEREAS, because of the complicated and confusing
records this Board deemed it proper to dig further into
these anomalies with the aid of experts from the Nation-
al Bureau of Investigation; and

"WHEREAS, on manifestation of Councilor Iñaki
Larrazabal to request the Chief or Director of the
National Bureau of Investigation to lend this City two
of his agents who are expert in auditing and record-
scrutinizing in order to help this Board look further
into these irregularities;

"NOW, THEREFORE, the Board, on motion of Councilor
Iñaki Larrazabal, seconded by Councilor Alvaro I.
Gutierrez;


"BE IT RESOLVED, AS it is hereby resolved, to request the Director of the National Bureau of Investigation, Manila, to send to Ormoc City two agents expert in auditing and record-scrutinizing to help the Municipal Board of Ormoc City dig into anomalies and confusing records in the office of the City Auditor, Ormoc City;

"RESOLVED FURTHER, to inform the Director of the National Bureau of Investigation that if this request be granted, the City of Ormoc is willing to pay for the travel of the two agents;


"RESOLVED FINALLY, to furnish copies of this Resolution to His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable Secretary of Finance, Manila; the Honorable Auditor General, Manila; the Director of the National Bureau of Investigation, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."


