RESOLUTION NO. 83

"WHEREAS, this Board has been informed of a coca-cola vendorlator being installed in the office of the department of engineering, this city;

"WHEREAS, this Board had made an ocular inspection of said coca-cola vendorlator and found same to be installed in said building and the plug of which is being connected to the line in the building coming from one general switch the output of which is measured by only one meter (electric current);

"WHEREAS, this Board is certain that the current consumed by said vendorlator is coming from the lines installed in the building and is being paid by the city government of Ormoc;

"WHEREAS, for the private use of a public property the Municipal Board of Ormoc City has got to be informed, the authority of which must originate from same;

"WHEREAS, this Board has never made a contract, come into agreement or authorized the installation of said vendorlator in the engineering department building;

"WHEREAS, for the installation of same in said building, somebody must have authorized, knowing fully well that said vendorlator is owned by a private firm;

"NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Coun. Teotimo Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to indorse this matter to the City Attorney, Ormoc City, requesting him to investigate on the issues surrounding the installation of the coca-cola vendorlator in the engineering department building and to authorize him to act on whatever action he deems proper on the matter, basing on his findings;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Attorney and the City Engineer, all of Ormoc City.


