RESOLUTION NO. 86

Resolution No. 294, passed by the Provincial Board of Tarlac on March 3, 1956, protesting with due respect, the implementation of Republic Act 1383, consolidating and centralizing all waterworks, sewerage and drainage systems in the Philippines under the control, direction and supervision of the National Waterworks and Drainage Authority and respectfully requesting the congress of the Philippines to pass a law during its present session repealing said Act, was presented.


NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with, Resolution No. 294 of the Provincial Board of Tarlac and to further PROTEST as this Body hereby PROTESTS, the implementation of Republic Act No. 1383 and with due respect most respectfully request the Congress of the Philippines to pass a law during its present session repealing said Act.




