RESOLUTION NO. 87

A RESOLUTION REQUESTING THE BUREAU OF FORESTRY
TO DIS-ESTABLISH COMMUNAL FOREST NO. 4, INC-
LUDED IN CADASTRAL LOT NO. 11286 SITUATED IN
SITIO, KANTILONG, BARRIO DOLORES, ORMOC CITY

"WHEREAS, Communal Forest No. 4, is included in
Cadastral Lot No. 11286 owned by Atty. Jorge S. Tan
of Ormoc City, having purchased the same from Mr.
Pelagio Codilla in 1939;

"WHEREAS, Said Communal Forest No. 4 is almost
cleared by Atty. Jorge S. Tan, the actual occupant
or possessor of same;

"WHEREAS, During the Cadastral Hearing of Lot No.
11286, the Bureau of forestry contested, because of the
existence of Communal Forest No. 4 inside said Lot;

NOW, THEREFORE, the Board, on motion of Councilor
Guillermo T. Parrilla, seconded by Councilor Jorge P.
Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to
request as this Body hereby requests the Bureau of
Forestry, Manila, to dis-establish Communal Forest
No. 4 which is included in Cadastral Lot No. 11286
situated in Sitio Kantilong, Dolores, Ormoc City, on
the ground that said forest is almost cleared by its
actual occupant or possessor, Atty. Jorge S. Tan;

"RESOLVED FINALLY, to furnish copies of this Reso-
lution each to the Director of Forestry, Manila; the
Forester, Bureau of Forestry, Ormoc City; the Honorable
City Mayor, the City Treasurer and the City Auditor, all
of Ormoc City.
