RESOLUTION NO. 82

"WHEREAS, the Municipal Board of the City of Roxas, in its Ordinary Session held on January 16, 1956, passed Resolution No. 5, petitioning President Ramon Magsaysay, through Congresswoman Carmen G. Consing to present a Bill to Congress amending certain sections of the Charter of the City of Roxas in such a manner as to make the Mayor, Vice-Mayor and all the City Councilors elective effective in the coming national elections of 1957;

"WHEREAS, Ormoc City is also one of the few chartered cities throughout the country whose inhabitants or electorate have been deprived of their rights of suffrage over the positions of the City Mayor and the Vice-Mayor;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with the embodiments of Resolution No. 5, current series, of the Municipal Board of the City of Roxas, and to request further as this Body hereby respectfully requests, His Excellency, President Ramon Magsaysay, thru Honorable Speaker Protempore Daniel Romualdez, House of Representatives, Manila, to present a Bill to Congress during this present session, making the positions of City Mayors, Vice Mayors and city councilors of all chartered cities whose Mayor, Vice Mayors and city councilors have not been elected in the elections of 1955 for provincial and municipal officials, elective effective in the coming national elections of 1957;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Hon. Speaker Protempore of the House of Representatives, Daniel Romualdez, Manila; the Municipal Board, Roxas City; the Honorable City Mayor, City Treasurer and City Auditor, all of Ormoc City;

"CARRIED UNANIMOUSLY."
