A RESOLUTION REQUESTING THE BOARD OF DIRECTORS OF THE NATIONAL  
WATERWORKS AND SEWERAGE AUTHORITY TO APPROVE THE TRANSFER  
OF P18,000 FROM OUT OF THE BALANCE OF THE WATERWORKS  
FUND OF ORMOC CITY TO THE GENERAL FUND OF THE CITY

"WHEREAS, there is a balance of P18,000 from the water-  
works fund of Ormoc City;

"WHEREAS, the Municipal Board of Ormoc City desires to  
transfer this balance of the waterworks fund to the general  
fund of the City;

"WHEREAS, the transfer of waterworks fund to the general  
fund requires the authority and approval of the Board of Direc-  
tors of the National Waterworks and Sewerage Authority;


NOW, THEREFORE, the Board, on motion of Councilor Guillermo  
T. Parrilla, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to request the  
Board of Directors of the National Waterworks & Sewerage Autho-  
rity, Manila, to approve the transfer of P18,000 from out of  
the balance of the waterworks fund of Ormoc City to the city's  
general fund, on the ground that there is at present a financial  
hardship of the general fund of the city;

"RESOLVED FINALLY, to furnish copies of this Resolution  
each to the Board of Directors of the National Waterworks A utho-  
rity, Manila; the Honorable City Mayor, the City Treasurer, the  
City Auditor, all of Ormoc City; and the Honorable Secretary of  
Finance, Manila;


