RESOLUTION NO. 99

"WHEREAS, Mr. Eutiquio Roque, of Bantigue, Isabel, Leyte, in his letter dated May 12, 1956 to this Board, requested that this Board indorse favorably in a form of a resolution, his application for a certificate of public convenience with the Public Service Commission, for operating a ferry service between Isabel, Leyte and Ormoc City via Merida;

"WHEREAS, this Board finds that the ferry service operated by the aforementioned applicant is commendable, the same having been operated efficiently to the satisfaction of the public;

NOW, THEREFORE, the Board, on motion of Councilor Jorge P. Tan, Jr., seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as is hereby resolved, to indorse favorably the application of Mr. Eutiquio Roque of Bantigue, Isabel, Leyte, for a certificate of public convenience for the operation of a ferry service between Isabel, Leyte and Ormoc City via Merida, and to request the Honorable Public Service Commission, Manila to issue to aforementioned applicant, a certificate of public convenience as requested;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Public Service Commission, Manila; the Municipal Council of Isabel, Leyte; the Municipal Council, Merida, Leyte; the Honorable City Mayor, the City Treasurer, the City Auditor, all of Ormoc City; and Mr. Eutiquio Roque, Bantigue, Isabel, Leyte.
