RESOLUTION NO. 100

Resolution No. 62, current series, of the Municipal Council of Surigao, Surigao, requesting the Honorable President of the Senate and the Honorable Speaker of House of Representatives, to sponsor a bill in congress, which if enacted into law, would cause the redemption by the National Government of the value of emergency notes and certificates of indebtedness paid for government taxes instead of cash during the post-war years, was presented.

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable President of the Senate, Manila; the Honorable Speaker of the House of Representatives, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City; and the Municipal Council of Surigao, Surigao.


