"BE IT RESOLVED, as it is hereby resolved, to reject as this Body hereby rejects the petition of the residents of Canlampag District, Ormoc City, to purchase from the City Government the land on which their houses are erected for reasons above stated and in the sense that Canlampag District has been reserved for furture public improvements.
