RESOLUTION NO. 104

"WHEREAS, By virtue of Resolution No. 60, series of 1951, the City Government of Ormoc granted and paid to claimant Engracio Limosnero the amount of P2.00 per square meter for his land traversed and utilized by the extension of Bonifacio Street, Ormoc City;

"WHEREAS, the area affected by said road extension has already been determined by the City Engineer;

"WHEREAS, claimant Vicente Torres for his land also traversed by the same extension and just adjoining the land of claimant Engracio Limosnero was appraised and paid at the rate of P6.00 per square meter;

"WHEREAS, to give fairness to all claimants whose lands were affected by the extension of Bonifacio street and to give them uniform payment this Body is deeming it fair to pay claimant Engracio Limosnero P6.00 per square meter of his land traversed by the extension of Bonifacio Street;

"NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Iñaki Larrazabal;


"BE IT RESOLVED, as it is hereby resolved, to adjust the road-right-of-way claim of Engracio Limosnero as paid by the city government at the rate of P2.00 per square meter to P6.00 per square meter;

"RESOLVED FURTHER, to appropriate the amount of P1,156.00 from out of City Roads and Bridge Fund to cover payment of the difference as a result of the above adjustment;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and Mr. Engracio Limosnero, all of Ormoc City.




