Ubay of Zamboanga del Norte, seeking to provide that fifteen percentum of the proceeds of tharges on forest products shall accrue to the municipality where such forest products are cut or taken;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable Secretary of Agriculture and Natural Resources, Manila; The Chairman of the Committee on Ways & Means, House of Representatives, Manila; each of the five congressmen of the Province of Leyte, all in Manila; the City Council of Basilan, City of Basilan; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City;
