RESOLUTION NO. 108

Resolution No. 94 of the Municipal Council of Baybay, Leyte, passed on May 15, 1956 requesting the Philippine Veterans Legion, National Headquarters, Manila, to make representations for and in behalf of the Western Leyte Guerrilla Warfare Forces for the latter's recognition, was presented.

"WHEREAS, it is evident that the officers and men of the Western Leyte Guerrilla Warfare Forces had made so much sacrifices during the dark days of the Japanese occupation to defend the freedom and liberties of the people of Western Leyte and for the cause of democracy;

"WHEREAS, for these heroic deeds and services which the members of the Western Leyte Guerrilla Warfare Forces have rendered to the people of Western Leyte and to the Liberation Forces, it would be unjust and unfair on the part of the authorities concerned not to recognize or to deny the recognition of the Western Leyte Guerrilla Warfare Forces;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Jorge P. Tan, Jr.;


"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with as this Body hereby concurs in and adheres with the embodiments of Resolution No. 94, current series, of the Municipal Council of Baybay, Leyte, and further request the Philippine Veterans Legion, National Headquarters, Manila, to make representations to the authorities concerned, for and in behalf of the members of the Western Leyte Guerrilla Warfare Forces for the latter's recognition;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Philippine Veterans Legion, National Headquarters, Manila; Congressmen Domingo Veloso of the Second District and Carlos Tan of the First District, both of Leyte and both now in Manila; the Municipal Council of Baybay, Leyte; the Provincial Board of Leyte; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.


