RESOLUTION NO. 113

"WHEREAS, schools are now opened and are still accepting enrolments, both in the primary and intermediate grades;

"WHEREAS, there is a standing policy of the Division Superintendent of Schools for Leyte, that any teacher now accepting enrolments and conducting classes whose number of pupils does not reach the minimum number of tupils required of their corresponding classes, should automatically be laid off;

"WARRAN, this Body has noted that enrolment in schools especially in the barrios are very slow and it no means will be undertaken by the school and barrio authorities, many classes are likely to be closed in the barrios;

extensive campaign encouraging parents to send their children to school, enrolment in all schools may yet ise above the minimum requirement as it is evident that there/many children in all barrios and even in the poblacion who are out of school;

"WHEREAS, the rearing of the youth, their education and training for civic, academic and vocational efficiency is the concern of all parents as provided by our Constitution;

"WHEREAS, by sending their children to school, the parents are in one way or another helping the government in the campaign to eliminate or at least lessen juvenile delinquency, as education in schools includes not only academic and vocational efficiency, but also educating the youth spiritually and morally;

NOW, THEREFORE, the Board, on motion of Councilor Teotimo Po Ocubillo, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to request all barrio councils throughout the City of

Ormoc to help the teachers campaign extensively to increase the enrolment in schools, and to encourage the parents to send their children to school;

"RESOLVED FURTHER, that in this campaign for enrolment, teachers and barrio officials be requested to campaign for the payment of taxes among barrio people in order to effect the collection of taxes due the government in due time;

"RESOLVED FINALLY, to furnish copies of this Resolution to His Honor, the City Mayor, the City Treasurer, the City Auditor, the City Supervisors of Ormoc, all barrio lieutenants and barrio councils throughout the City; all of Ormoc City.

"CARRIED UNANIMOUSLY."
