RESOLUTION NO. 114

"WHEREAS, the City of Ormoc has provided the Police Department and the City Engineer each with a jeep for official use of each corresponding department;

"WHEREAS, after each accident the jeeps were taken to the Engineering Garage purposely for repairs and reconditioning;

"WHEREAS, many months have elapsed and the jeeps have not as yet been returned to their corresponding departments repaired or reconditioned;

"WHEREAS, this Body doubts as to the fate of these jeeps, perhaps some persons must have tampered with the spare parts believing that the City will no longer need them as they have already been damaged;

"WHEREAS, this Body desires this matter investigated and settled out in due time in order to know the fate of the jeeps above-mentioned;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to indorse this matter to the City Attorney, Ormoc City, for investigation and at the same time, requesting the City Attorney to file charges against anybody responsible on the matter, should his investigation warrant the filing of charges against these people;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, and the City Attorney, all of Ormoc City.
