RESOLUTION NO. 115

"WHEREAS, this Body has been informed reliably that a minor (15 years old) has been abused by a certain fellow who has been dismissed from the Police force of Ormoc City for the same offense;

"WHEREAS, this is the third time that this same fellow committed the same crime (rape);

"WHEREAS, the abused girl and her parents had been asking the City Attorney of Ormoc City to file a rape charge against the culprit;

"WHEREAS, for some reasons that this Board can not well understand, the City Attorney has time and again refused to file the case with the Municipal Court of Ormoc;

"WHEREAS, on manifestation of Councilor Iñaki Larrazabal to inform the Honorable Secretary of Justice about this matter and to request the Honorable Secretary to send an investigator to Ormoc City to investigate on this case;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Esteban C. Conejos;

"BE IT RESOLVED, as it is hereby resolved, to inform the Honorable Secretary of Justice by wire that the Assistant City Attorney of Ormoc, who is presently acting as City Attorney, refuses to file a rape case which has been committed on Sunday, June 10, 1956;

"RESOLVED FURTHER, to request the Honorable Secretary of Justice to send to Ormoc City a special investigator to investigate on this matter;


"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Secretary of Justice, Manila; His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable City Mayor, the City Auditor, the City Treasurer, all of Ormoc City.

"CARRIED UNANIMOUSLY."


