RESOLUTION NO. 112

A RESOLUTION AMENDING RESOLUTION NO. 109, C.S.
OF THIS BOARD, IN SUCH A MANNER AS TO AU-
THORIZE ATTY. RAFAEL D. OMEGA, ACTING
CITY TREASURER, ORMOC CITY, TO
COLLECT SALARY DIFFERENCE

"WHEREAS, in accordance with Republic Act No.
840, City Treasurer Rafael D. Omega is entitled to
a salary of ₱4800.00 per annum or ₱400.00 monthly;

"WHEREAS, actually, Acting City Treasurer Ra-
fael D. Omega is receiving only ₱4200 per annum or
₱350.00 per month;

"NOW, THEREFORE, the Board, on motion of Coun-
cilor Alvaro I. Gutierrez, seconded by Councilor
Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to
appropriate the amount of ₱435.48, from any funds
existing in the city treasury not otherwise appro-
priated, to be made available for the payment of
the salary difference of Acting City Treasurer Ra-
fael D. Omega, for the period from October 10, 1955
to June 30, 1956, as a result of salary adjustment
from ₱350 to ₱400 per month, in accordance with
Republic Act No. 840;

"RESOLVED FURTHER, that by virtue of this Reso-
lution, Resolution No. 109, current series, of this
Board, be as it is hereby, amended and modified ac-
cordingly, in accordance with this Resolution;

"RESOLVED FINALLY, to furnish copies of this
Resolution, each to the Honorable City Mayor, the City
Treasurer and the City Auditor, all of Ormoc City.
