RESOLUTION NO. 122

"WHEREAS, some parts of the flooring of Sabang Bao Elementary School building are already rotten, and for being so, there is a danger that it might collapse under the weight of the pupils and teachers;

"WHEREAS, Councilor Esteban C. Conejos informed this Board that the other week, a part on the floor of said building collapsed under the weight of a pupil causing injury to said pupil which sent her to one of the hospitals in the city for treatment;

"WHEREAS, the Principal Teacher of Sabang Bao Elementary School has made representations to this Body through the councilor of Sabang Bao, requesting an aid from the city for the repair of Sabang Bao Elementary school building;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of ₱200.00 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the expenses of repairs of the Sabang Bao Elementary School building;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the City Supervisor, Ormoc II District, the Principal, Sabang Bao Elementary School, all of Ormoc City.
