RESOLUTION NO. 124

Resolution No. 330, c.s., of the Provincial Board of Capiz concurring in and adhering with Resolution No. 274, c.s., of the Provincial Board of Misamis Occidental, requesting the Philippine Government, through His Excellency, the President of the Philippines, and Congress to negotiate with the President of the United States for the return of the amount of ₱70,000,000.00 that was then earmarked for the payment of the arrears-in-pay and other benefits to which the Filipino war veterans of World War II were entitled, was presented.

"WHEREAS, this Board agrees with the Honorable Provincial Boards of Misamis Occidental and Capiz that the return of the said amount to the United States Government has been a great mistake which prejudiced so much the Filipino veterans;

NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilors Emilio C. Penserga and Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with the embodiments of Resolution No. 330, c.s., of the Provincial Board of Capiz and Resolution No. 274, c.s., of the Provincial Board of Misamis Occidental.




