RESOLUTION NO. 108

"WHEREAS, this Board, on June 2, 1956, adopted Resolution No. 108, requesting the National Commander of the Philippine Veterans Legion to make representations to the authorities concerned, for and in behalf of the members of the Western Leyte Guerrilla Warfare Forces for the latter's recognition;

"WHEREAS, the National Commander of the Philippine Veterans Legion, upon receipt of the said Resolution No. 108 of this Board, transmitted the contents thereof to Congressman Tolentino, Majority Floor Leader of the House of Representatives with the request that the matter be brought up in a government-to-government negotiation between the United States and the Philippines;

NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Esteban C. Conejos;

"BE IT RESOLVED, as it is hereby resolved, to request Congressman Arturo M. Tolentino, Majority Floor Leader, House of Representatives, Manila, to consider action on the letter of Alfredo M. Bustamante, National Commander of the Philippine Veterans Legion, dated June 18, 1956, re recognition of the Western Leyte Guerrilla Warfare Forces;;

"RESOLVED FINALLY, to furnish copies of this Resolution each to Rep. Arturo M. Tolentino, Majority Floor Leader, House of Representatives, Manila; the National Commander, Philippine Veterans Legion, Manila; the Hon. City Mayor, the City Treasurer, the City Auditor, all of Ormoc City; and Maj. Teofilo Moncada, Ormoc City.
