RESOLUTION NO. 126

A RESOLUTION AUTHORIZING THE CIVIL AERONAUTIC ADMINISTRATION
TO CONSTRUCT A TERMINAL OFFICE BUILDING ON THE PROPOSED
HOSPITAL SITE ADJACENT TO THE RUNWAY AT COGON
COMBADO, ORMOC CITY

"WHEREAS, this Body has been informed of the donation of
P5,000 by Honorable Daniel Z. Romualdez to the Civil Aeronautic
Administration, for the construction of a terminal office
building adjacent to the runway at Cogon Combado, Ormoc City;

"WHEREAS, the site selected by the CAA authorities on
which to construct the proposed terminal office building has
been proposed as the city hospital site;

"WHEREAS, the CAA authorities made representations to this
Body requesting an authority to construct their terminal office
building on the proposed hospital site;

NOW, THEREFORE, the Board, on motion of Councilor Alvaro
I. Gutierrez, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to withdraw a
portion of the proposed city hospital site adjacent to the
runway at Cogon Combado, Ormoc City, an area sufficient to
accommodate the terminal office building of the Civil Aeronautic
Administration;

"RESOLVED FURTHER, to authorize the Civil Aeronautic Ad-
ministration to construct a terminal office building on this
withdrawn portion of the city hospital site adjacent to the
runway at Cogon Combado, Ormoc City

"RESOLVED FINALLY, to furnish copies of this Resolution
each to the Honorable City Mayor, the City Treasurer, the City
Auditor, the City Engineer, the City Health Officer, the Mana-
ger, the CAA, Manila;

"CARRIED UNANIMOUSLY."
