RESOLUTION NO. 127

"WHEREAS, this Board has been informed of an Order of Preliminary Mandatory Injunction of the Court of First Instance at Ormoc City in the case of Potenciano Larrazabal et al vs. Palami et al, docketed as Sp. Proc. No. 135-0, ordering the reinstatement of Palami and others whose positions in the City Government have been abolished by virtue of Resolution No. 8, current series, of this Board;

"WHEREAS, in view of the fact that it was the Municipal Board who abolished said positions and on the case filed and docketed as Sp. Proc. No. 135-0, the Mayor, the Treasurer and the Auditor have been made the underdogs of said abolition whereby the Municipal Board deems it proper to sustain the Mayor, the Treasurer and the Auditor in the aforementioned case by authorizing them to put up a bond to dissolve the writ of preliminary injunction filed against the City Mayor, the City Treasurer and the City Auditor; and

"WHEREAS, the City Treasurer, as custodian of the properties of the City Government of Ormoc, is hereby authorized to secure and put up as bond the necessary properties of the City Government of Ormoc for the dissolution of the order of preliminary mandatory injunction in the case of Palami et al vs. Potenciano Larrazabal et al docketed as Sp. Proc. No. 135-0 in the Court of First Instance of Ormoc City;

NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to authorize the Honorable City Mayor of Ormoc to sign the bond in behalf of the City Government in the amount of ₱16,000 to dissolve the order of Preliminary Mandatory Injunction of the Court of First Instance in the case of Palami et al vs. Potenciano Larrazabal et al docketed as Sp. Proc. No. 135-0;

"RESOLVED FINALLY, to furnish copy of this Resolution each to the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City."
