by the Municipal Board for maintenance of city health, social  
welfare and charitable work based upon the recommendation of the  
chief of the health department;

"WHEREAS, the City Health Officer, Ormoc City, in a 2nd  
indorsement dated July 11, 1956 recommended that this amount  
of P151.98 covered by the check mentioned above be applied as  
partial payment of the account of the City Health Department  
in Manila thru the purchase of vaccines since 1948 up to the  
present which is amounting to P5,155.50;

"BE IT RESOLVED, as it is hereby resolved, to appropriate

No. PC-01510 for the payment (partial) of the account of the  
City Health Department with the Department of Health, Manila,  
for the purchase of vaccines since 1948 which until the present  
remains unpaid, and amounting to P5,155.50;
