RESOLUTION NO. 131

"WHEREAS, the NAWASA is presently drilling an ar-
tesian well in barrio Linao, Ormoc City;

"WHEREAS, before this artesian well was drilled
it was agreed that the site of this well must be halfway
between Linao and Naungan, since these barrios have al-
ready artesian wells;

"WHEREAS, the well as it is now constructed is loca-
ted on a site not previously agreed at Sitio Lim-og;

"WHEREAS, out of pity to the people of Lim-og, this
Board wishes to request the NAWASA representative at
Ormoc City to tap a one-inch pipe from the well extending
to the Sitio of Lim-og before the termination of the
construction of the well;


NOW, THEREFORE, the Board, on motion of Councilor

Parrilla;


"BE IT RESOLVED, as it is hereby resolved, to re-

extend to Sitio Lim-og;


"RESOLVED FINALLY, to furnish copies of the Reso-
