Inaki Larrazabal, seconded by Councilor Cesar Samson;


"BE IT RESOLVED, as it is hereby resolved, to adopt the

as the decision of this Board on said administrative case;


"RESOLVED FINALLY, to furnish copies of this Resolution
