"WHEREAS, it has come to the attention of this Board that the ferry service of the Aboitiz and Co. between Ormoc and Cebu is getting poorer;

"WHEREAS, during the previous months, the company use to send two boats to Ornoc, one alternating with the other every other day arriving and leaving on time as scheduled:

from Ormot to Webu are getting plentiful nowadays, the company is assigning only one boat to call at Ormoc City, causing passengers to be stranded at Ormoc on the days when there is no boat;

WHENENS, at times the boat leaves very much in advance of the time schedule leaving unaware passengers on port:

NOW, THEREFORE, the Board, on motion of Councilor Teo mo P. Ocubillo, seconded by Councilor Jorge P. Tan, Jr.;

"BE IT RESOLVED, as it is hereby resolved, to call the attention of Aboitiz and Co., Cebu City, of the inefficient ferry service they are giving to the riding public between Ormoc and Cebu and to request the same company to send a bigger boat or another boat to alternate with the one now plying between Ormoc and Cebu every other day, so as not to delay passengers especially those coming from far away places, and to request further, that these boats leave on schedule and not in advance of the scheduled time;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Manager, Shipping Department, Aboitiz & Co, Cebu City; the Hon. City Mayor, the City Treasurer, the City Auditor, all of Ormoc City.
"CARRIED UNANIMOUSLY."
