RESOLUTION NO. 138

"WHEREAS, the Acting Chief of Police, in his communication to this body dated July 20, 1956 requested that an appropriation of ₱21.00 be allotted for the travel of Pat. Montederamos to San Fernando, Cebu, in order to liquidate his cash advance;


NOW, THEREFORE, the Board, on motion of Councilor Jorge P. Tan, Jr., seconded by Councilor Cesar Samson;




