RESOLUTION NO. 139

"WHEREAS, due to the opening of Bonifacio Street extension certain parcels of lots have been traversed and used by the city for this particular improvement;

"WHEREAS, one of the lots traversed by Bonifacio Street Extension is one which is owned by the Western Leyte College, Ormoc City;

"WHEREAS, for the payment this lot traversed by said extension, the same has been appraised at P3.00 per square meter by the Appraisal Committee;

"WHEREAS, some of the lots traversed by the same extension and just adjoining this lot owned by the Western Leyte College were appraised at a much higher rate per square meter;

"WHEREAS, on manifestation of Councilor Guillermo T. Parrilla to request the Appraisal Committee of Ormoc City to ~~re~~consider a reappraisal of the lot owned by the Western Leyte College traversed by Bonifacio Street Extension in such a manner as to equalize the same to previous lots appraised by said Committee as regards to rate per square meter;

NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, request the Appraisal Committee, Ormoc City, to reappraise the lot owned by the Western Leyte College traversed by Bonifacio Street Extension in such a manner as to equalize the same to previous lots appraised by said Committee as regards to rate per square meter;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and the Director, Western Leyte College, all of Ormoc City.
