RESOLUTION NO. 143

"WHEREAS, this Board has noted that some residents and properties along the Anilao River are endangered due to the possibility that the force of the river during a big flood might break a weak portion of a certain parcel of land which is holding the course of the river and causing it to detour to another direction;

"WHEREAS, this parcel of land which is holding the course of the river has a thickness of only around two meters and it is quite possible that in case of a big flood this thickness of unreinforced soft land can not withstand the force of the river and if this happens it is eminent that residents of Mabini and Sabang Districts will be endangered;

"WHEREAS, it is high time that this matter be given preferential attention as the rainy season where floods occur every now and then is fast approaching;

"WHEREAS, at present there is no source of fund by which the City can get to remedy this dangerous situation;

NOW, THEREFORE, the Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to request the Director of Public Works to authorize the City Engineer of Ormoc to use any public works fund available for preventive remedies to avert any eminent danger and to protect lives and properties both private and public;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Public Works, Manila; the Hon. City Mayor, the City Treasurer and the City Auditor, all of Ormoc.

"CARRIED UNANIMOUSLY."
