"RESOLVED FINALLY, to furnish copies of this Resolution each to the Provincial Governor, Tacloban City; the Provincial Assessor, Tacloban City; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Assessor, all of Ormoc City.
