RESOLUTION NO. 149

"WHEREAS, Mr. Gregorio Sacay, of Cagbuhangin, this city, made representations to this Body, requesting to repurchase his lot situated at Cagbuhangin which was purchased by the City Government from him for the use of the city nursery located in the same barrio;

"WHEREAS, on manifestation of Councilor Guillermo T. Parrilla, that instead of selling said lot, Mr. Gregorio Sacay be authorized to occupy and cultivate said lot as a tenant and that the produce thereof be shared between him and the City of Ormoc on a 70-30 basis;

NOW, THEREFORE, the Board, on motion of Councilor Emilio C. Penserga, seconded by Councilor Guillermo T. Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to authorize and allow Mr. Gregorio Sacay or his authorized representative, to cultivate and plant a lot which was formerly owned by him situated in the City Nursery compound at Cagbuhangin as a tenant, the produce of which will be shared between him and the City Government on a 70-30 basis, and to continue as a tenant thereof until such time when the city may be able to maintain the nursery.

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, all of Ormoc City; and Mr. Gregorio Sacay of Cagbuhangin, Ormoc City.
