RESOLUTION NO. 152

"WHEREAS, the Barrio Lieutenant of Linao, Ormoc City, reported to this Board that some people in Linao are settling themselves in the supposed to be school site of Linao Elementary School;

"WHEREAS, these people squatting on the school site aforementioned can not be ejected therefrom because according to them they are paying rentals for occupying the land to the heirs of the late Teodoro Conui;

"WHEREAS, because of the foregoing, there arises now a problem as to whether the land on which these squatters are occupying belongs to Teodoro Conui or to the school site of Linao;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to request the City Engineer, Ormoc City, to relocate the boundaries of the school site of Linao Elementary School so as to settle the foregoing question once and for all;

"RESOLVED FURTHER, to request the Bureau of Lands, Ormoc City, to furnish this Board and the City Engineer, the technical description of the Linao school site;

"RESOLVED FURTHERMORE, that the heirs of the late Teodoro Conui or their authorized representative be present at the time of the survey;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Engineer, the City Treasurer, the City Auditor, the Bureau of Lands, the Administratrix of the late Teodoro Conui, all of Ormoc City.

"CARRIED UNANIMOUSLY."
