RESOLUTION NO. 157

Letter of the Asst. Civil Engineer, In-Charge of Office  
of the City Engineer, Ormoc City, quoted verbatim hereunder,  
follows:

"The Honorable City Board  
Ormoc City

"Gentlemen:

"The area taken by the city government for road purposes along Bonifacio St. Extension and San Jorge St. Extension both of this city for lot No. 1387 of Ormoc Cadastre is one-thousand and one hundred seventy (1170) sq.m. more or less.

"In this connection, it is requested that an amount of seven thousand and twenty pesos (P7,020.00) be appropriated or set aside to pay the affected lot in question.

"It is informed that the Appraisal Committee has appraised the affected lots at six pesos (P6.00) per sq. meter.

"WHEREAS, Mr. Sanchez, the owner of the lot aforementioned made representations to this Body to take favorable action on the above request of the City Engineer;

"WHEREAS, other lot owners whose lots were also traversed by the same Bonifacio St. extension were already paid of their road right-of-way claims;

"WHEREAS, to give justice to Mr. Sanchez this Body deems it wise to pay Mr. Sanchez of his road right-of-way claim just as the others were;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of Seven Thousand Twenty Pesos (P7,020.00) from out of the local Roads and Bridge Fund, to be made available for the payment of 1170 square meters of land from lot No. 1387, used by the city government in the extension of Bonifacio Street, Ormoc City;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer and Mr. Hermogenes Sanchez, all of Ormoc City.

"CARRIED UNANIMOUSLY."




