## RESOLUTION NO. 159

"WHEREAS, last August 4, 1956 the Municipal Board of Ormoc City and the City Engineer wired the Secretary of Public Works and Communications requesting an aid from the National Government for the construction of a dyke to fortify the portion of the Anilao River banks at Cogon Combado so as to protect lives and property and the national highway:

"WHEREAS, the Secretary of Public Works, in his telegram to the City Engineer last August 6, 1956 stated that his department has no runds for flood control and suggested that local funds be set aside for the purpose;

making this rejuest to the national government because the city as of the present has no source of funds by which this purpose can be met;

"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to request as this Body hereby requests, His Excellency, the President of the Philippines, to give a public works project to Ormoc City, particularly the construction of a dyke at Cogon-Combado along the Anilao River, which is endangering lives and property and possible destruction of the public highway;

"RESOLVED FURTHER, to send this Resodution to His Excellency immediately by wire;

"RESOLVED FINALLY, to furnish copies of this Resolution each to His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, all of Ormoc City; "CARRIED UNANIMOUSLY."
