RESOLUTION NO. 163

Resolution No. 239, current series, of the Provincial Board of Sulu, petitioning the President of the Philippines, to extend his support to said resolution by directing the drafting and submission to Congress of the Philippines of a Bill giving a small participation from the proceeds of Customs Collections to provinces and cities derived from their respective territorial jurisdictions, was presented.

"WHEREAS, this Body believes that with the passage and approval of this requested Bill, the corresponding provinces and cities recipient of the participation would be able to carry on further the President's program of ameliorating the rural areas with these increases in revenue, by giving out projects to the benefit of the barrio people;

NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Alvaro I. Gutierrez;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with, the embodiments of Resolution No. 239, current series, of the Provincial Board of Sulu, and to request further, His Excellency, the President of the Philippines, to cause to be presented to Congress, a Bill which would seek to give a small participation from the proceeds of Customs Collections to provinces and cities derived from their respective territorial jurisdictions;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Provincial Board of Sulu, Jolo; His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable Speaker of the House of Representatives, Manila; each of the five congressmen of the Province of Leyte, all in Manila; the Honorable City Mayor, the City Treasurer, the City Auditor, all of Ormoc City; and Hon. Daniel Z. Romualdez, House of Representatives, Manila.
