RESOLUTION NO. 169

Resolution No. 188, current series, of the Municipal Board of the City of Dumaguete, requesting Congressmen Lorenzo G. Teves and Lamberto E. Macias of Negros Oriental to make representations with Secretary of Finance to certify to the Secretary of Public Works and Communications the inability of the City of Dumaguete to put up the required counterpart fund in an amount equal to that given to same City from the Highway Special Fund, so that the balance thereof shall be released, and requesting that said balance be released earlier instead of at the end of the fiscal year as provided for in Republic Act 917;

"WHEREAS, Ormoc City is meeting the same problem as that of the City of Dumaguete in putting up the required counterpart fund;

NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Cesar Samson,

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with the embodiments of Resolution No. 188 of the City of Dumaguete, and to request as this Body hereby requests the five congressmen of the Province of Leyte to make representations to the Honorable Secretary of Finance to certify to the Secretary of Public Works and Communications the inability of Ormoc City to put up the required counterpart fund, requesting further, that the balance thereof be released as early as possible.

"RESOLVED FINALLY, to furnish copies of this Resolution each to the five congressmen of the Province of Leyte, all in Manila; the Municipal Board of the City of Dumaguete; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
