RESOLUTION NO. 170.

BE IT RESOLVED, as it is hereby resolved, to ask the President of the Ormoc Puericulture Center and Maternity House to reject the bid now awarded to one, Placido Enecio, and that the same be rebidden allowing engineer-contractors from Cebu who may be interested to participate in the bid;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Health Officer and the President, Ormoc Puericulture Center and Maternity House, all of Ormoc City.

"CARRIED UNANIMOUSLY."




