RESOLUTION NO. 180

"WHEREAS, this Board, in its regular session last August 25, 1956, passed resolution No. 152 requesting the City Engineer, Ormoc City, to re-survey or relocate the boundaries of Linao Elementary School so as to settle once and for all a question of ownership to a parcel of land now occupied by private persons claimed to be owned by the heirs of the late Teodoro Comui but which this Body believes to be owned by the City Government of Ormoc and allocated for school site purposes in barrio Linao;

"WHEREAS, this Body came to understand that without a technical description of the lots comprising the school site aforementioned a relocation of its boundaries seems to be impossible;

"WHEREAS, last September 5, 1956 the Honorable City Mayor wrote to the Director of Lands requesting for a technical description of the lots aforementioned and which was duly furnished and received on September 29, 1956;

"WHEREAS, with this technical description of lots comprising the school site of barrio Linao now on hand, this Board believes that a relocation of its boundaries can now be effected;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to reiterate the request of this Body embodied in Resolution No. 152, current series, requesting the Office of the City Engineer, Ormoc City, to undertake the relocation of the boundaries of Linao Elementary School site with the technical description furnished this Office by the Bureau of Lands, Manila, as the bases;


"RESOLVED FURTHER, to request the heirs of the Late Teodoro Comui to be present during the relocation or re-survey;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Commissioner of Public Highways, Manila; the Division Highway Engineer, Cebu City; the Honorable City Mayor, the City Treasurer, the City Auditor, the City Engineer, the heirs of the late Teodoro Comui and the Principal, Linao Elementary School, all of Ormoc City.


