RESOLUTION NO. 182

"WHEREAS, Dr. Jose Mercado Jr., City Health Officer, Ormoc City, in his communication to this Body dated October 10, 1956 requested an authority for payment of his salary difference as City Health Officer of this city from May 2, 1953 to October 17, 1953 at ₱100 per month or a total of ₱555.64;

"WHEREAS, considering the plight of Dr. Mercado and his efficient service to the government of Ormoc City, this Body deems it just to consider and approve his request for payment of his differential pay;

"NOW, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilors Cesar Samson and Iñaki Larrazabal;


"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of ₱555.64 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the payment of the salary difference of Dr. Jose Mercado Jr., City Health Officer, Ormoc City, from May 2, 1953 to October 17, 1953;

"RESOLVED FURTHER, that this amount be incorporated in the coming supplemental budget that this Board will make for the governmental expenses of Ormoc City not incorporated in the fiscal budget submitted to the Department of Finance;



"CARRIED UNANIMOUSLY."


