"BE IT RESOLVED, as it is hereby resolved, to request the corn and rice mill operators of Ormoc City who protest the enforcement of Ordinance No. IX, series of 1956, to put their objections in writing; and

"RESOLVED FURTHER, that as soon as their protest is received by the Secretary of the Board, the same be referred to the Board committees on Laws and Ordinances and Zonification, for further study and recommendation to the Board;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the Board Committee Chairmen of Laws and Ordinances and Zonification and Mr. Jaime D. Omega, spokesman of the Corn and Rice Mill Operators of Ormoc City, all of Ormoc City.
