RESOLUTION NO. 189

"WHEREAS, the District Land Officer, Tacloban City, in his communication to this Body dated October 26, 1956, stated that records in his office show that Lot No. 1346 of the Ormoc Cadastre is, at the time of survey, claimed by the Municipal Government of Ormoc;

"WHEREAS, the same communication of the District Land Officer said that several squatters are now occupying Lot No. 1346 and that the same has been defaulted as per records of the Cadastral Court;

"WHEREAS, Ormoc City is still interested in the acquisition of the same lot in question;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilors Teotimo P. Ocubillo and Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to refer this matter to the City Attorney, Ormoc City, for proper action;

"RESOLVED FURTHER, to inform the City Attorney, Ormoc City, that the City Government of Ormoc is still interested in acquiring Lot No. 1346 of the Ormoc Cadastre;

"RESOLVED FURTHERMORE, to request the City Attorney, Ormoc City, to inform the District Land Officer, Tacloban City, of this action;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor, the City Attorney, all of Ormoc City; and the District Land Officer, Tacloban City.
