RESOLUTION NO. 194

"WHEREAS, the City of Ormoc is in receipt of her shares from the Philippine Charity Sweepstakes draw held on September 17, 1956, August 26, 1956, and October, 1956; in the amount of P36.98, P59.73 and P46.74, respectively;

"WHEREAS, as provided by law, this share may be allotted by the Municipal Board for maintenance of city health, social welfare and charitable work based upon the recommendation of the chief of the health department;

"WHEREAS, the City Health Officer, Ormoc City, recommended that the amounts stated above covered by PC Check Nos. 02057, 02140 and 01982, Ormoc City's share from the Philippine Charity Sweepstakes, be spent for the repairs of the public dispensary building;

"AND, THEREFORE, the Board, on motion of Councilor Alvaro I. Gutierrez, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P143.45, Ormoc City's share from the Philippine Charity Sweepstakes, covered by Check Nos. PC-02057, P46.74; PC-02140, P36.98; and PC-01982, P59.73, for the repairs of the public dispensary building;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Health Officer, all of Ormoc City;
