RESOLUTION NO. 197

Resolution No. 317, current series, of the Provincial Board of Camarines Norte, requesting the Honorable, the Commissioner of Civil Service, to recognize those policemen and officers who have successfully passed the retraining courses and the final examination given by the Board, as third grade civil service eligibles at least, in order that they may not be subjected to the whims and fancy caprices of politicians who want to eliminate incumbents to accommodate their own proteges, was presented.

"WHEREAS, this Board well knows that in previous administrations several policemen who were trained and have successfully passed retraining courses for policemen in the service, have been arbitrarily dismissed without cause, just so to accommodate proteges of some politicians;

"NOW, THEREFORE, the Board, on motion of Councilor Teotimo P. Ocubillo, seconded by Councilor Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to concur in and adhere with, as this Body hereby concurs in and adheres with, the embodiments of Resolution No. 317, current series, of the Provincial Board of Camarines Norte and to request further as this Body hereby requests, The Honorable Commissioner of Civil Service, to recognize those policemen and officers now in the service who have passed police retraining courses as third grade civil service eligibles;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Commissioner of Civil Service, Manila; the Secretary, Provincial Board of Camarines Norte, Daet; the Honorable City Mayor, the City Treasurer, and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
