RESOLUTION NO. 198

"WHEREAS, this Board, on October 27, 1956 passed Resolution No. 189, requesting the City Attorney, Ormoc City, to study and inform this Board of his findings, on a lot in question, numbered 1345, of the Ormoc Cadastre, which, according to the records of the Bureau of Lands, Tacloban office, had been defaulted by the Cadastral Court;

"WHEREAS, as per records of the Bureau of Lands and the Court of First Instance, the claim of the city government of Ormoc is on Lot No. 1346 instead of Lot No. 1345 as it actually is;

"NOW, THEREFORE, the Board, on motion of Councilor Esteban C. Conejos, seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to request the City Attorney, Ormoc City, to make the necessary adjustments and/or correction with the Court of First Instance, Ormoc City, in such a way that the records of the Bureau of Lands, the Court of First Instance and the Cadastral Court will conform with each other and that the claim be transferred to Lot No. 1345 instead of Lot No. 1346;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer, the City Auditor and the City Attorney, all of Ormoc City.
