RESOLUTION NO. 199

"WHEREAS, on representations made by Mr. Jose A. Leuterio before this Body, this Board, on January 7, 1956 passed a resolution granting him the right, privilege and authority to operate a telephone service system in Ormoc City, in accordance with Act. No. 667, as amended by Act No. 1022, subject to the approval of the Public Service Commission and the President of the Philippines;

"WHEREAS, since the passage of said resolution granting him said right and privilege to operate a telephone service system in Ormoc City more than eleven months had elapsed, but this Board has not been informed of any development or effort made by Mr. Jose A. Leuterio to establish the telephone system and to implement the franchise granted him under Resolution No. 13, dated January 7, 1956, of the Municipal Board of Ormoc City;

"WHEREAS, this Body learned that Mr. Jose A. Leuterio has never made any move to show that he is still interested in operating a telephone service system in Ormoc City, the fact that he has never made any representation with the Public Service Commission for the approval of the aforestated Resolution-franchise in his favor;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Emilio C. Penserga;

"BE IT RESOLVED, as it is hereby resolved, to repeal, and this Body hereby repeals, Resolution No. 13, passed on January 7, 1956, for the reason that Mr. Jose A. Leuterio has completely failed to comply with the conditions set forth in said Resolution;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Public Service Commission, Manila; His Excellency, the President of the Philippines, Malacañang, Manila; the Honorable Secretary of Public Works & Communications, Manila; the Honorable City Mayor, the City Treasurer, the City Auditor and the City Engineer, all of Ormoc City.
