RESOLUTION NO. 21A

"WHEREAS, the Philippine National Bank, with the city officials of Ormoc, will inaugurate the PNB branch in Ormoc City this coming January 4th, 1957;

"WHEREAS, in said inauguration it is the desire of this Board to avail of the services of the III MA Band at Cebu City, to assist in the ceremonies which may be performed in connection thereto;

"WHEREAS, this Board wishes to inform the III MA Band, thru Gen. Cornelio Bondad, that the City Officials of Ormoc are willing to pay the services of the Band in assisting the inauguration;

"WHEREAS, this Board has experienced that the rate charged by the Band in assisting the last festivities of Ormoc City was a little bit high;

"WHEREAS, it is the intention of this Board to request the III MA Band, thru Gen. Cornelio Bondad that the price which will be charged by the Band in assisting the forthcoming inauguration of the PNB Branch at Ormoc City, be reduced;

"NOW, THEREFORE, the Board, on motion of Councilor Cesar Samson, seconded by Councilor Guillermo Parrilla;

"BE IT RESOLVED, as it is hereby resolved, to request the III MA Band, thru Gen. Cornelio Bondad, to assist the inauguration of the PNB Branch at Ormoc City this coming 4th of January, 1957;

"RESOLVED FURTHER, to request said Band, thru Gen. Bondad, that the price at which the Band will charge for assisting the inauguration be lower than that charged by the same band in assisting the last festivities of Ormoc City;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, Ormoc City; Gen. Cornelio Bondad, III MA Commander, Cebu City; the City Treasurer, and the City Auditor, all of Ormoc City.


