RESOLUTION NO. 215

"WHEREAS, in a letter to the Honorable City Mayor and indorsed to this Board, the Radio Control Board Secretary informed that the President of the Philippines has approved the release of one set of radio receiver for the barrio of Catayum, Ormoc City;

"WHEREAS, according to the same letter the above mentioned radio receiver set should be taken from the Radio Control Board Office within 45 days from the date of said communication (Dec. 14, 1956) by a duly authorized representative of the Mayor;

"WHEREAS, Councilor Alvaro I. Gutierrez has informed this Board that he is going to Manila sometime within this week;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla, seconded by Councilor Teotimo P. Ocubillo;

"BE IT RESOLVED, as it is hereby resolved, to authorize as this Body hereby authorizes, Dr. Alvaro I. Gutierrez, a member of this Board, to take the delivery of the receiver set mentioned in the letter of the Secretary, Radio Control Board of December 14, 1956, which is intended for Barrio Catayum, Ormoc City;

"RESOLVED FURTHER, to authorize Dr. Alvaro I. Gutierrez, to follow up the other Resolutions of this Board filed with the Radio Control Board, requesting to provide the barrios of Ormoc City with radio receiver sets;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable Secretary, Radio Control Board, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
