RESOLUTION NO. 220

"WHEREAS, Councilor Guillermo T. Parrilla manifested before this Board that the newly constructed toilet in the public market premises needs some sort of improvement because the pit which holds the waste does not have an outlet; that after few months use the pit will be filled and the toilet will no longer be of service to the public;

"WHEREAS, Mr. Tiburcio Liston, the contractor of the toilet, explained that an opening can be made on the cement wall of the pit facing the creek which can be opened during flood thus emptying the pit of its waste contents every now and then;

"NOW, THEREFORE, the Board, on motion of Councilor Guillermo T. Parrilla; seconded by Councilor Iñaki Larrazabal;

"BE IT RESOLVED, as it is hereby resolved, to appropriate the amount of P400 from out of any funds existing in the city treasury not otherwise appropriated, to be made available for the construction of an outlet from the pit of the toilet in the public market, and for such other improvements as the City Treasurer may deem necessary;

"RESOLVED FURTHER, that the improvements thereon, be done by administration;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.

"CARRIED UNANIMOUSLY."
