RESOLUTION NO. 5

A RESOLUTION REQUESTING THE DIRECTOR OF LAND
TRANSPORTATION TO ESTABLISH A MOTOR VEHICLES
AGENCY IN ORMOC CITY.

"WHEREAS, with the implementation of reorganiza-
tion plan No. 60 relative to public utilities regula-
tion and land transportation embodied in Executive
Order No. 209, dated October 19, 1956, the Motor Ve-
hicles Office in Ormoc City will have to be abolished;

"WHEREAS, as a result of the abolition of the
present motor vehicles office in Ormoc City, motor
vehicles in Ormoc City and the rest of the municipa-
lities in Western Leyte will have to go to Tacloban
City for registration, the fact that there is only
one registering office in Leyte under the present
set up if implemented;

"WHEREAS, considering the fact that Tacloban
City is 109 kilometers from Ormoc City and between
these places there is a barrier of mountains and
rough roads, it will be very inconvenient on the part
of motor vehicle operators in Ormoc City and the
other towns in Western Leyte to go to Tacloban City
for registration; and

"WHEREAS, considering further that for the last
year there were some 700 vehicles registered in Ormoc
City with a collection of ₱105,000, the establishment
and maintenance of a motor vehicles agency in Ormoc
City will be justified;

"NOW, THEREFORE, the Board, on motion of Coun-
cilor Guillermo T. Parrilla, seconded by Councilor
Cesar Samson;

"BE IT RESOLVED, as it is hereby resolved, to
request as this Body hereby requests, the Director
of Land Transportation, Manila, to establish a motor
vehicles agency in Ormoc City to take care of the
registration of motor vehicles in Ormoc City and the
whole western Leyte, for the reasons above stated;




