"RESOLVED FURTHER, that in the event that the Bureau of Telecommunications ceases to operate a radio station in Ormoc City or refuses or fails to utilize these lots for the purpose, said lots shall be returned to the city government of Ormoc;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Telecommunications. Manila; the Honorable Speaker Protempore of the House of Representatives, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City. "CARRIED UNANIMOUSLY."
