RESOLUTION NO. 8

"WHEREAS, in his letter to this Board dated December 15, 1956, Acting Director of Telecommunications P. Taracatac requested the adoption of a resolution covering the donation of the site for the message center measuring 23 meters by 38 meters, and the other site for the transmitting station measuring 48 meters by 69 meters;

"WHEREAS, it is to the best interest to the city government and the people of Ormoc City to have a radio station in this city;

"NOW, THEREFORE, The Board, on motion of Councilor Iñaki Larrazabal, seconded by Councilor Alvaro I. Gutierrez;


"BE IT RESOLVED, as it is hereby resolved, to donate as this Body hereby donates, a portion of the cemetery site in Can-adieng measuring 48 x 69 meters and a portion of the lot adjoining the dispensary building measuring 23 x 38 meters, to the Bureau of Telecommunications, to be utilized by said bureau for the installation of a message center and transmitting station;

"RESOLVED FURTHER, that in the event that the Bureau of Telecommunications ceases to operate a radio station in Ormoc City or refuses or fails to utilize these lots for the purpose, said lots shall be returned to the city government of Ormoc;

"RESOLVED FINALLY, to furnish copies of this Resolution each to the Director of Telecommunications, Manila; the Honorable Speaker Protempore of the House of Representatives, Manila; the Honorable City Mayor, the City Treasurer and the City Auditor, all of Ormoc City.
